# ***Cremated Remains Vault Regulations***

## ***Exclusive Right Of Burial***

- 1 *The vault space in which exclusive right of burial of cremated remains has been granted shall be kept and used solely as a burial place for cremated remains and no other use shall be made.*
- 2 *The party in whose favour the right of burial has been granted ["the Proprietor"] (and his/her heirs or successors) may not dispose of or sell this right without the written permission of the Company. However, the Proprietor may assign the right as part of their heritable estate.*
- 3 *In cases where there is no will, the right of burial shall pass to the eldest child. Where there are no children, the eldest representative according to the rules of heritable succession of the Law of Scotland shall succeed.*
- 4 *No heir (or successor) of the Proprietor shall have any right or interest, nor exercise that right, in the vault space until he/she has provided satisfactory evidence to the Company.*
- 5 *The exclusive right of burial of cremated remains will be granted for a period of **twenty five years** or until the Cemetery is no longer used as a burial ground. At the end of the twenty five year period the heirs or successors of the Proprietor may renew the exclusive right of burial of cremated remains for a period and fee fixed at that time by the Company. If it is not reasonably possible to trace the heirs or successors, or if the heirs or successors decline the option to renew the exclusive right of burial of cremated remains, then the exclusive right of burial of cremated remains in the vault space shall default to the Company. The Company will then be entitled to apply for permission to exhume the cremated remains and dispose of them in a dignified fashion according to the methods of disposal of cremated remains available at that time.*
- 6 *The Proprietor (and his/her heirs and successors) will only be entitled to exercise the right of burial of cremated remains in the vault space upon payment of the interment fees which will be fixed from time to time by the Company.*

## ***Erection of Memorials***

- 7 *No enclosing walls, fence or building shall be erected in the vicinity of the vaults in which the exclusive right of burial of cremated remains has been granted.*
- 8 *No memorial plaque other than that supplied by the Company shall be fixed to the vaults.*
- 9 *It will be the responsibility of the Company to maintain any memorial plaque fixed to the vault.*
- 10 *Fresh cut flowers may be placed in an area designated by the Company, but no other memorials may be placed.*

## ***Works within the Cemetery***

- 11 *No works of any kind will be permitted in the cemetery, unless authorised by the Company. The Superintendent will determine when any works can be carried out. All workmen will be responsible to the Superintendent, who may ask them to leave if they cause any offence.*
- 12 *Materials used shall be of the best quality and works must be completed with the minimum of delay. All refuse remaining after works have been completed must be removed immediately.*

## ***General***

- 13 *Visitors to the Cemetery are expected to conduct themselves in an appropriate manner. Dogs must be kept on a leash at all times, and must not be allowed to intimidate other visitors, or the local wildlife. The Superintendent has the right to refuse admission to the Cemetery.*
- 14 *The Proprietor (and his/her heirs or successors) will be bound by such rules and regulations as the Company may from time to time bring into effect.*
